

RESOLUTION APPROVING THE GENERAL PREVAILING HOURLY WAGE RATES FOR ALL LABORERS, MECHANICS AND OTHER WORKMEN EMPLOYED FOR WORK CONTRACTED BY STEPHENSON COUNTY, ILLINOIS

WHEREAS, it is the policy of the State of Illinois that a rate of no less than the general prevailing hourly rate as paid for work of similar character in the locality in which the work is performed, shall be paid to all laborers, mechanics and other workmen, by or on behalf of any and all public bodies engaged in public works, and

WHEREAS, the State of Illinois, therefore, has enacted "An Act Regulating Wages of Labors, Mechanics and other Workmen employed in any Public Works by the State, County, City, or any Public Body or any Political Subdivision or by anyone under Contract for Public Works", 820 ILCS 130/1 through 130/12, of the Illinois Compiled Statutes 1992, and

WHEREAS, 130/9 of the aforesaid Act requires that Stephenson County, each fiscal year, establish the general prevailing rate of hourly wages to paid laborers, mechanics, and other workmen in the locality of Stephenson County, Illinois, employed by contractors or subcontractors in performing construction and maintenance of public works contracted for by Stephenson County, Illinois.

NOW THEREFORE, BE IT RESOLVED BY THE COUNTY BOARD OF STEPHENSON COUNTY, STATE OF ILLINOIS THAT:

SECTION 1: Contractors or subcontractors doing construction and maintenance of public works for Stephenson County, Illinois shall pay the general prevailing rate of hourly wages to all laborers, mechanics, and other workmen employed by them as determined by the Department of Labor of the State of Illinois for the locality of Stephenson County. SECTION 2: The County Clerk is hereby authorized and directed to cause this Resolution to be published in a local newspaper of general circulation, to publicly post and keep available for public inspection in the Office of the County Clerk this determination, or any revisions of such prevailing rate of wage, and to promptly file a certified copy of this Resolution with the Illinois Department of Labor at Springfield, Illinois, all as by law prescribed where after the same shall be in force and effect as by law provided.

SECTION 3: The general prevailing rate of hourly wages for all labors, mechanics, and other workmen hereby adopted shall be in effect for Stephenson County, Illinois beginning June 1, 2015 and ending May 31, 2016.
